**AKC NEWS**

The Board VOTED to approve a request from the Portuguese Podengo Pequenos of America club (their parent club) to allow the Portuguese Podengo Pequenos to be eligible to participate in AKC Lure Coursing events. The breed is not allowed to compete for Best in Field, due to its small size. Effective date is January 1, 2012.

The Reserve Best In Show award is approved for all-breed shows, effective July 3, 2012.

As of January 1, 2012, the fee to register a dog will be raised from 20 to \$30.
